SUBJECT: FAILURE TO TIMELY FILE PRE-ELECTION REPORTS

Dear Mr. Cannard:

We have reviewed the reports submitted to the Commission on February 9, 1995 and we noted a lack of timeliness in the filing of those reports.

Under Public Disclosure law, political committees supporting or opposing ballot propositions to be held on February 7, 1995 are required to file a summary of contributions and expenditures (PDC Form C-4) on the following dates during the special reporting period four months prior to the election:

- * 21-day pre election C-4 report: DATE DUE January 17, 1995;
- * 7-day pre-election C-4 report: DATE DUE January 31, 1995;
- * Post-election C-4 report: DATE DUE March 10, 1995.

There is some concern regarding a lack of timeliness in filing your C-3 and C-4 reports. The C-3 reports which contain contributor information for the Friends of Light Rail should have been filed the same day the bank deposit was made. In addition, the 7-day pre-election C-4 report filed on February 9, 1995, contained expenditure information related to the election which was not made available to the public until after the election. The C-4 report was filed nine days late on February 9, 1995, and included \$143,087.41 in contributions received, and \$145,456.91 in expenditures made during the period in question.

In addition, we have received an informal inquiry regarding two pieces of political advertising apparently sponsored by your committee (See enclosed copies). Those advertisements are as follows:

- * the ad placed in The Columbian which ran on Monday, February 6, 1995 entitled "Let's Keep Clark County on Track"; and
- * the brochure entitle "Light Rail-Fact vs. Fiction".

"The public's right to know of the financing of political campaigns and lobbying and the financial affairs of elected officials and candidates far outweighs any right that these matters remain secret and private."

RCW 42.17.010 (10)

The sponsor identification on both pieces of political advertising should have included the words "paid for" or "sponsored by", the complete mailing address of the organization sponsoring the advertisement, be in a printed or drawn box, be in at least 10 point type, and appear on each page of the publication (front and back):

It appears that the brochure was sponsored by the Friends of Light Rail Committee, and should have included the following, "Paid for by the Friends of Light Rail, 5305 E. 18th St.-Suite A, Vancouver, Wa. 98661-9969", all drawn inside of a box.

However, the sponsor of the newspaper advertisements which appeared in The Columbian is unclear due to Schedule B to C-4 report dated February 9, 1995. Included in the C-4 report is \$11,379.41 of in-kind contributions from The Columbian for inserts and advertisements. In order to resolve this matter, please respond to the following questions:

* Who paid for the newspaper advertisements which appeared in The Columbian prior to the election?

* Did the Friends of Light Rail committee provide the text and layout for the advertisement? Did The Columbian provide the advertising space, and how was that arranged?

The Commission has adopted the following policy with regard to political advertising which does not contain the proper sponsor identification:

a) First violation: "staff will send written notice of the infraction to the person or committee, containing the requirements for adhering to the law. A memorandum will be included in the file.

b) Second violation: "If after notice has been sent by staff, the advertisement still fails to conform with the requirements, the person or committee will be afforded an opportunity to stipulate to the facts, correct the violation(s), and pay \$50 for each violation. The settlement is brought to the Commission for approval".

c) "If a settlement agreement cannot be reached, the matter will be scheduled for a single commissioner hearing".

d) "Allegations against a person or committee which has previously been found to have been in violation of RCW 42.17.510 or .520 shall be heard in a single commissioner hearing".



Normally we would ask that you take corrective action on all future political advertising undertaken by your campaign to ensure the sponsorship identification requirements are met. However, since the election has been held, this written notice will be placed on your file as your warning for all future elections.

The staff of the Commission is requesting you to submit a response no later than March 30, 1995, regarding the apparent lack of timeliness in the filing of your campaign reports and the issues regarding sponsor identification on the two pieces of political advertising. Your response will determine what action, if any will be taken.
